## 2019 MANISTEE NATIONAL FOREST FESTIVAL FLEA MARKET RULES

EXHIBITOR hereby contracts with the Manistee Area Chamber of Commerce for booth space at the Manistee National Forest Festival Flea Market as follows:

1. EXHIBITOR agrees to use and pay for booth space as described. EXHIBITOR agrees to accept space assigned and will not sub-let to anyone else. EXHIBITOR agrees to provide proof of liability insurance naming the Manistee Area Chamber of Commerce as an additional insured.
2. Neither the Manistee Area Chamber of Commerce, the Manistee National Forest Festival Committee, nor the City of Manistee will be responsible for any injury which may arise to EXHIBITORS, their employees, or agents, or guests or customers, or for the loss or theft of or damage to any display, merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in the Festival Flea Market. By executing this contract, EXHIBITOR agrees absolutely and irrevocably to waive and release any claim it may have against the Manistee Area Chamber of Commerce, the Manistee National Forest Festival, the City of Manistee, their officers, officials, agents or employees.
3. When ACTS OF GOD or any other causes not within the control of the Manistee Area Chamber of Commerce, City of Manistee, or the Manistee National Forest Festival Committee make it impossible for the EXHIBITOR to occupy the Flea Market premises, then in such case the Manistee Area Chamber of Commerce, the Manistee National Forest Festival Committee, and the City of Manistee, their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The EXHIBITOR also agrees to the following conditions of this contract:
  - a. No illegal weapons (switch blades, brass knuckles, etc.)
  - b. No vulgar or pornographic materials or merchandise.
  - c. Individual generators may be used until *11:15 p.m.* only.
  - d. Only merchandise specified in contract may be exhibited or sold.
  - e. Booth sharing by exhibitors is not permitted.
  - f. The EXHIBITOR agrees to use qualified labor at all times.
  - g. The management shall be entitled to close an exhibit at any time for failure of EXHIBITOR to perform, observe and comply with any term set forth in the contract.
  - h. EXHIBITOR shall not be entitled to a refund or any part of any fee should he/she, for any reason, is unable to exhibit.
  - i. If for any reason the management determines that the location of the Flea Market should be changed or dates should be changed, management reserves this right.
  - j. All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed. Possession and/or sale of drug paraphernalia or encouraging or suggesting illegal activities are prohibited by City of Manistee ordinance. **NO POT LEAVES MAY BE DISPLAYED OR SOLD.**
  - k. EXHIBITOR will keep dogs on a leash and be responsible for cleaning up after the animal per the City of Manistee ordinance.
  - l. EXHIBITOR will cooperate by keeping Flea Market area clean.
  - m. Garage sale merchandise is not permitted.
  - n. Exhibits left over-night are at the EXHIBITORS own risk.
  - o. The management has the right to ask the exhibitor to take down any items that may be offensive or cause controversy or complaints from customers.

**In all cases, decisions of the Flea Market Master and Manistee National Forest Festival Officials are final. Failure to abide by decisions of the Flea Market Master may result ejection from the show without refund.**
