## 2021 MANISTEE NATIONAL FOREST FESTIVAL FLEA MARKET GUIDELINES

EXHIBITOR hereby contracts with the Manistee Area Chamber of Commerce (MANAGEMENT) for space at the Manistee National Forest Festival as follows:

- EXHIBITOR agrees to use and pay for booth space as described. Booth sharing is not permitted. Only merchandise specified in the contract may be exhibited or sold.
- EXHIBITOR agrees to accept space assigned and will not sub-let to anyone else.
- EXHIBITOR agrees to provide proof of liability insurance naming the Manistee Area Chamber of Commerce as an additional insured.
- EXHIBITOR agrees to abide by all pertinent laws, ordinances, current Michigan Department of Health and Human Services (MDDHS) COVID-19 protocols, and regulations pertaining to health and public safety. MANAGEMENT reserves the right to cancel and void this contract 20 days before the event without penalty.
- The Manistee Area Chamber of Commerce, nor the City of Manistee are not liable for any injury which may arise to
  EXHIBITOR, their employees, agents, guests, or customers; or for the loss, theft of or damage to any display,
  merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in the
  Manistee National Forest Festival.
- The EXHIBITOR is responsible for the fair value of any damages caused to Rotary Park and Douglas Recreation Area during their time at the festival by the vendor, its guests or invitees.
- If an ACT OF NATURE or any other causes not within the control of the Manistee Area Chamber of Commerce or the
  City of Manistee make it impossible for the EXHIBITOR to occupy the Festival premises, then in such case the
  Manistee Area Chamber of Commerce and the City of Manistee, their officers, officials, agents or employees are
  jointly released from any and all claims for damages which may arise as a consequence thereof.
- The EXHIBITOR also agrees to the following conditions of this contract:
  - -No illegal weapons (switchblades, brass knuckles, etc.)
  - -No vulgar or pornographic materials/merchandise.
  - -Possession and/or sale of drug paraphernalia or encouraging or suggesting illegal activities are prohibited by the City of Manistee ordinance.
  - -Garage sale merchandise is not permitted.
  - -Individual generators may only be used until 11:00 pm.
  - -Exhibits left overnight are at the EXHIBITOR's own risk.
- EXHIBITOR agrees to use qualified labor at all times.
- MANAGEMENT shall be entitled to close an exhibit at any time for failure of EXHIBITOR to perform and/or comply
  with any term set forth in this contract.
- EXHIBITOR shall not be entitled to a refund should he/she/they, for any reason, be unable to exhibit.
- MANAGEMENT reserves the right, for any reason, to change the dates or the location of the Flea Market during the Festival.
- EXHIBITOR will keep dogs on a leash and be responsible for cleaning up after the animal, per the City of Manistee ordinance.
- · EXHIBITOR will cooperate by keeping the Flea Market area clean and organized.
- MANAGEMENT has the right to take down any items that may be offensive, cause controversy, or complaints from customers. In all cases, the decisions of the Flea Market Manager and Manistee National Forest Festival Officials are final. Failure to abide by their decisions may result in ejection from the show without a refund.
