If you have more than one media, you must apply separately for each. PLEASE INCLUDE A SELF ADDRESSED, STAMPED ENVELOPE WITH YOUR APPLICATION.

EXHIBITORS ARE RESPONSIBLE FOR THEIR OWN LIABILITY INSURANCE

Applications must be postmarked by April 1, 2023. Jury selection results will be mailed by April 30, 2023. Upon acceptance into the show, there will be no refund of your fee. ALL JURY DECISIONS ARE FINAL. Show is limited to 90.

RULES: To ensure fairness to all participating artists and the public, ALL WORK MUST BE ORIGINAL. Artwork must be consistent with the submitted photos. No artwork from kits or other commercial methods, no imported or other resale items, and no commercial clothing is allowed. Only the work of the accepted artist may be sold or displayed. Artists selling unacceptable items or work not consistent with submitted photos will be asked to remove the objectionable items from the booth.

<u>Artists must be present both days</u>. Artist's booth and merchandise must stay intact until 5 p.m. Sunday. The committee has the right to remove from the show any exhibitor not abiding by the rules without refund. It also has the right to exclude any exhibitor to limit the number of entries in any category or who is not consistent with the rules.
