JURYING: Applicants must submit a photo of their current work. Please label it with your name, address, and media.

EXHIBITORS ARE RESPONSIBLE FOR THEIR LIABILITY INSURANCE

Applications must be postmarked by June 1, 2025. Upon acceptance into the show, your fee will not be refunded. ALL JURY DECISIONS ARE FINAL.

RULES: To ensure fairness to all participating artists and the public, ALL WORK MUST BE ORIGINAL. The artwork must be consistent with the submitted photos. No artwork from kits or other commercial methods, no imported or other resale items, and no commercial clothing is allowed. Only the work of the accepted artist may be sold or displayed. Artists selling unacceptable items or work not consistent with submitted photos will be asked to remove the objectionable items from the booth. **No parking on the grass.**

Artists must be present on both days. Artist's booth and merchandise must stay intact until 5 pm Saturday, unless other arrangements are made. The committee has the right to remove from the show any exhibitor not abiding by the rules without a refund. It also has the right to exclude any exhibitor to limit the number of entries in any category or who is not consistent with the rules.
